Agreement of Services for the 2022-23 SY between
The Alachua Multi-County Title 1, Part C, Migrant Education Program
And the Hamilton County Public Schools


Purpose: To assist in the removal of educational barriers for migrant students, and to ensure that migrant students have access to an equitable and appropriate public-school education as any other public-school student. To increase attendance and academic achievement of children including preschoolers and out of school youth, identified as children of migrant workers.

The Hamilton County school district contracts with the Alachua Multi-County Title 1 Part C, Migrant Education Program to provide program services to Hamilton County migrant students and out of school youth. The Alachua Multi-County Migrant Education Program will comply with the following Florida Department of Education (FLDOE) guidelines, as well as provide the following services for eligible migrant students and youth:

1. Identification and recruitment (ID&R) of migrant students and Out of School Youth (OSY).
2. Submit to the FLDOE all documents related to compliance with state guidelines.
3. Coordinate with districts within the consortium for the timely submission of migrant students' data.
4. Provide supplemental academic services to Priority of Service migrant students in academic need, to include individual and/or group tutorials in core subjects, secondary credit accrual and secondary testing strategies.
5. Coordinate migrant student academic and social services with school and district personnel such as principles, guidance counselors, teachers and federal programs directors.
6. Serve as a liaison between the migrant student's home and school by facilitating the scheduling of parent/teacher/school staff meetings, and by providing transportation when possible.
7. Provide parent involvement activities and support the attendance of district sponsored parent involvement activities by the distribution of fliers and transportation where possible.
8. Provide migrant parents, students and out of school migrant youth with information about the educational services available to them.

9. Provide out of school migrant youth the opportunity to re-enroll in public schools and enroll in diversified learning opportunities, such as adult and vocational educational education.
10. Assist in the registration of school and ensure that children have access to preschool programs including extended day.
11. Identify migrant preschool children and ensure that families and children receive assistance in enrolling in Head Start, VPK, and other preschool programs available in the district.
12. Coordinate with child development and preschool program personnel and other social services agencies to provide comprehensive services.
13. Coordinate with community service agencies such as community education providers, libraries, University and community colleges, shelters, food banks, outreach programs, childcare providers, welfare and housing agencies, public health departments.
14. Provide Outreach materials to families to enable direct access to community resources.


