In accordance with the Request for Proposal, I, Frederick L. Koberlein, Sr., am pleased to submit this Letter of Transmittal. We will use the paragraph numbering of paragraph 3.c. of the RFP.

(1) The work to be done.

Many believe that all a School Board Attorney does is sit in meetings and keeps his/her mouth shut. Actually, attendance at the public meetings is just the tip of the iceberg. Being a school board attorney involves extensive review and interpretation of federal, state, and local laws and ordnances. It involves the application of present or predicted facts and circumstances to those laws and regulations. Ideally, it involves solving problems before they become problems, which is far less expensive. It is our belief that the "Work to be Done" by the next Hamilton County School Board Attorney encompasses, at a minimum, the foregoing.

I and the Law Firm, Koberlein Law Offices ("KLO"), are committed to being ready to perform the Work to be Done. Prior to being appointed as a judge, I was the Columbia County School Board Attorney for ten years. We currently represent several other state political subdivisions among which are: The City of Lake City and The City of Live Oak as well as two other cities and a hospital board. # **EXPERIENCE OF LAW FIRM AND ATTORNEYS**

This response uses the paragraph numbering of the Request for Proposal paragraph 3. d.

- (1) Koberlein Law Offices, PLLC ("KLO") is a local law office. The primary office is in Lake City, Florida.
- (2) The location of the KLO office from which the work is to be done will be the Lake City office at 855 Baya Avenue, Lake City, Florida. KLO is solely owned and operated by Frederick L. Koberlein, Jr. In addition to him, there are two attorneys, Frederick Koberlein, Sr. and Megan Standard; the firm employs one paralegal, one law clerk, and two other staff.
- (3) Frederick Koberlein, Sr. has ten years of experience as the Columbia County School Board Attorney. He left that position in good standing; he was appointed to a judicial position. He also has more than two years of experience as Assistant City Counsel to two municipalities.

Frederick Koberlein, Jr. has many years of experience representing local government bodies and state political subdivisions, each consisting of numerous elected officials. He is certified by the Florida Bar in the area of City, County, and Local Government Law.

Megan Standard has six years of experience representing various local government bodies.

- (4) The Florida Bar has not taken any disciplinary action against any member of the firm.
- (5) Within the past five years, (and continuing to the present) the firm has represented:

#### **Minimum Qualifications**

- (1) I graduated from the Florida State University School of Law, with honors, in December 1978.
- (2) I was admitted to the Florida Bar in 1979.
- (3) I have twenty-six years of experience as an attorney and thirteen years of experience as a judge in Florida.

### **Preferred Qualifications**

- (1) I am a member of the Florida Bar, the Trial Bar of the United States Court for the Middle District of Florida and the Bar of the Eleventh Circuit Court of Appeals.
- (2) I have ten years of experience in, and knowledge of, the laws applicable to a School Board Attorney; I was the attorney for the Columbia County School Board for ten years. I was a member of the Florida School Board Attorneys Association for ten years; during which I took advantage of almost every educational opportunity. I have attended and will attend continuing education courses to maintain competency and currency in general areas of law applicable to school boards; i.e. government in the sunshine, public records, awarding contracts (procurement).

### **Preferred Performance Criteria**

- (1) As the attorney for the Columbia County School District for ten years, I obtained an excellent working knowledge of school board policies, state, federal, and administrative laws relating to the area of School Board Attorney.
- (2) As an attorney for many years and a Judge for thirteen years, I have an excellent knowledge of judicial proceedings, rules of evidence, and methods of research. I routinely undertake many more continuing education hours than the required minimum.
- (3) In addition to the school board background set forth above, I have two years of experience as Assistant City Attorney for the City of Lake City, the City of Live Oak, and the Town of Fort White which provide me with more than a mere general knowledge of local government law.

- (4) I have excellent skills in conducting research and preparing sound legal opinions. For example, while I was the Dixie County Judge, I handled thousands of cases. No County Court opinion or judgment was reversed or overruled.
- (5) I have the ability to interpret and apply legal principles and precedents in resolving complex legal problems. See response (4) above.
- (6) Although my voice has become raspy, I am still able to communicate clearly and concisely, both orally and in writing.
- (7) I have in the past and can effectively participate in the preparation and presentation of civil litigation matters before State and Federal Courts. I recently completed a case in the U.S. District Court; I have several state court cases pending.
- (8) I can also effectively participate in the preparation and presentation of civil litigation matters before the Division of Administrative Hearings. I have one administrative case pending.
- (9) My successful tenure as an attorney in the public sector and as a judge demonstrate my ability to establish and maintain effective working relationships with public officials, management, staff, subordinates, and the general public. I believe that I work well with my employers.
- (10) I have a proven record of excellence in legal counseling and advising senior management or boards. In addition to my school board experiences, I have been a member of, or represented numerous lesser boards such as: American Red Cross, Three Rivers Legal Services, Inc., Columbia County Humane Society, St. James' Episcopal Church, and several local service organizations.
- (11) I recently was instrumental in drafting the voluminous multi-party (City, Developer, Owner, Primary Lenders, and Secondary Lenders) contract for the City of Lake City to facilitate the Blanche Project (a designated historical project requiring additional regulations). The total contract length exceeded 80 pages. I have drafted numerous other documents including proposed school board policies.
- (12) In addition to representing public bodies, I have represented several private corporations and institutions. I have a general knowledge of their governance issues and concerns. (See response 10 above.)

- (13) I have ten plus years of experience with Florida School Laws. I am familiar with and have general knowledge of the Florida Department of Education laws and rules.
- (14) In addition to the highly regulated education industry, I have recent experience in reviewing and explaining portions of the Federal Aviation Rules. Pre-law, I was a naval carrier pilot; the intense regulations there were a matter of survival.
- (15) Since leaving the Navy, I have not been called upon to directly manage more than ten people at any given time; however, often my recommendations to public administrators involve multitudes. As set forth above, I have legal analysis and writing skills.
- (16) One of my strengths is listening. I am especially adept at listening to professional employees when they are explaining an area about which my knowledge is limited. My lengthy successful career is evidence of my ability to work with professionals and lawyers. A consensus is superior to a "best day in court."

As is set forth above, we have requested, via a public records request, the legal fees for the School District for the past eighteen (18) months. We have relied upon those expenses in trying to ascertain a fair fee for the School District. The RFP states, "*The fee structure should include a retainer for basic services … Other rates may be provided for work outside the scope of basic services.*" In accordance with that provision:

KLO suggests a monthly retainer fee of \$2,000.00 for the basic services listed in the RFP.

KLO suggests \$120.00 per hour for non-litigation work outside the scope of basic services.

It is our intention to leave you with the impression that our Proposal is the most responsible due, in large part, to the approach that we have taken to determine what the School Board's legal needs are and where we can save the School Board over the course of time. For example, in the six months of this calendar year, your legal expenses have been in excess of \$75,000.00. We respectfully suggest that the School District's savings in the near and distant future will be significant.
